

HEAD COACH FOR WOMEN'S SOCCER ATHLETICS

POSITION SUMMARY:

The Head Coach is responsible for administering all aspects of the women's soccer program, adhering to the guidelines and expectations that are set forth from Villa Maria College and the USCAA. In addition to the day-to-day coaching, the Head Women's Soccer Coach is responsible for the organization of scheduling, budget, travel coordination, game day staff management, equipment management, camps, and fundraising. In addition to these responsibilities, the Head Women's Soccer Coach is expected to meet recruiting and retention goals.

QUALIFICATIONS:

- Previous soccer coaching experience, with preference given to collegiate level experience.
- Bachelor's degree preferred.
- Candidates should have strong interpersonal and leadership skills and ability to recruit quality student-athletes.
- Must be able to work evenings and weekends throughout the season and off-season.
- Must have a current/valid NYS driver's license and an acceptable driving record.
- Candidate must demonstrate a strong professional work ethic and commitment to the academic success of students.
- Must be goal oriented, able to motivate teams and collaboration among student team members.
- Practice planning, skill development, game planning, bench management.
- Adherence to USCAA, conference, departmental, and college policies, procedures and expectations.
- Ability to recruit and scout potential players.
- Administrative responsibilities as they pertain to team operations.
- Lead with program operations.

Essential Functions and Duties:

- Recruit, retain and graduate successful student-athletes
- Meet the recruitment and retention goals set by the College
- Plan season competition schedule, coordinate travel, plan and conduct practices
- Ensure academic performance and personal development of student-athletes
- Collaborate with Admissions and Financial Aid administration
- Maintain a high level of professionalism on and off the field toward student athletes, other
- coaches, parents, administrators, and members of the community
- Monitor and manage women's soccer budgets and program resources
- Coordinate and develop fundraising plans, camps and clinics

- Maintain a clear understanding and adhere to USCAA bylaws
- Additional administrative responsibilities will be assigned at the discretion of the Director of Athletics

WORK ENVIRONMENT:

General work environment requires employees to consistently use manual dexterity in reaching, writing, navigating around the office/workspace. This position requires fully functional vision and auditory abilities. This position may include hours standing and walking, including up and down stairs, moving items of up to 30-pounds. Occasional evening and weekend hours may be needed to perform work associated with this position. If the position requires use of vehicle for College purposes, a valid New York State driver's license check may be required for occasional off-campus assistance and support.
